# **Community update**

January 2025

# Eastern Green Link 3 (EGL 3) and Eastern Green Link 4 (EGL 4) form part of The Great Grid Upgrade, the largest overhaul of the electricity grid in generations, which aims to build a more secure and resilient future energy system.

In April 2024, we invited communities to share their views on our proposals for EGL 3 and EGL 4 – two new primarily offshore electricity links, with associated onshore infrastructure, between Scotland and England.

The links aim to, on completion, transport enough clean energy from Scotland to power up to four million homes in the Midlands and South of England, playing an important role in the decarbonisation of the UK electricity grid.

#### Our first stage of public consultation

Between April and July 2024, we held our first round of public consultation, known as a non-statutory consultation, on our early proposals. Thank you to all those who took part. We received hundreds of responses from members of the public, landowners, district and county councils, parish and town councils, and local and national organisations. We are currently in the process of reviewing all feedback received. Your comments are extremely valuable and are helping us develop and refine our proposals in advance of our second round of consultation, known as a **statutory consultation**, planned for this year.

As part of our application for development consent, we will prepare a consultation report. This report will set out all the feedback we received throughout our public consultations, along with how we have had regard to that feedback. Our proposals for EGL 3 and EGL 4's onshore infrastructure in England currently comprise of:

- Underground cables
  - A substation
- Converter stations
- A direct current switching station

#### **Surveys**

We are currently in the process of carrying out technical and environmental surveys on the area we have identified as the potential route for the underground cables, on surrounding land that may be impacted, and in areas that may have been identified through feedback as potentially sensitive.

These surveys are to assess the landscape, ecology and cultural heritage aspects of the area, and to inform further detailed environmental assessments.

All survey information gathered will be published either as part of our preliminary environmental information report, which helps us to fully understand and appreciate the area proposed to host our projects, at our next round of consultation or to support our application for a development consent order. This information will be publicly available on our website.
